**ORDINANCE NO. 458**

**AN ORDINANCE AMENDING CHAPTER 315 OF THE  
CODE OF THE BOROUGH OF TRAPPE PERTAINING TO  
PARKING REGULATIONS, BRIDGE WEIGHT LIMITS  
AND PEDEDTRIAN CROSSINGS IN THE BOROUGH OF  
TRAPPE.**

Be it **ORDAINED** and **ENACTED** by the Borough Council, Borough of Trappe, Montgomery County, Pennsylvania, and it is hereby **ENACTED** and **ORDAINED** by the authority of same as follows:

**SECTION 1.** The Code of the Borough of Trappe, Chapter 315, Section 315-43, **Traffic Signal Locations**, is hereby amended by adding the following:

West Main Street and Trappe Center  
West Main Street and Fifth Avenue  
West Main Street and Seventh Avenue.

**SECTION 2.** The Code of the Borough of Trappe, Chapter 315, Section 315-44 is hereby amended to read as follows:

**§315-44 Intersections Where No Turn on Red.**

**SECTION 7.** The Code of the Borough of Trappe, Chapter 315, Section 315-52, **Streets Where Truck Traffic Is Restricted**, is hereby amended by deleting **“Betcher Road Between East Seventh Avenue and East Third Avenue”** and **“East Seventh Avenue Between West Main Street and Betcher Road”**.

**SECTION 8.** The Code of the Borough of Trappe, Chapter 315, Section 315-54 is hereby amended to read as follows:

**§315-54 Schedule II-A: Locations Where Parking Is Prohibited at All Times.**

**SECTION 10.** The Code of the Borough of Trappe, Chapter 315, Section 315-63, **Pedestrian Control Signals**, is hereby amended by adding the following:

**SECTION 11.** The Code of the Borough of Trappe, Chapter 315, Section 315-64, **Pedestrian Crossing Regulations**, is hereby amended by adding the following:

**SECTION 12. Severability**

The provisions of this Ordinance are intended to be severable, and if any section, sentence, clause, part or provision hereof shall be held illegal, invalid or unconstitutional by any Court of competent jurisdiction, such decision of the Court shall not affect or impair the

remaining sections, sentences, clauses, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Borough Council that this Ordinance would have been adopted even if such illegal, invalid or unconstitutional section, sentence, clause, part or provision had not been included herein.

**SECTION 13. Repealer**

All other ordinances or parts of ordinances and any resolutions or parts thereof in conflict with this Ordinance are hereby repealed.

**SECTION 14. Effective Date**

This Ordinance shall take effect and be in force from and after its approval as required by the law.
