Pool/Hot Tub Permit Application

Construction/installation of any structure that is intended for swimming or recreational bathing that contains water 24 inches (610 mm) or deeper. This includes in-ground, above-ground & on-ground swimming pools, hot tubs and spas.

If there will be 2,000 sq. feet or more of earth disturbance in the construction of the proposed structure, then an approved Grading Permit is required. Please refer to Borough Code §179 "Grading & Stormwater Management" for specific requirements.

Grading Permits shall be submitted to the Zoning Officer with two sets of plans. Storm water retention must be addressed in documentation submitted with the Grading Permit Application (including calculations to support the design).

Please be aware separate application is required for any/all of the following if planned as part of/associated with the installation

- Electrical, Fence, Deck, etc.
- Fence/Barriers must be in compliance with - International Residential Code® 2015 International Pool & Spa Code
