**RESOLUTION APPOINTMENT OF THE TRAPPE BOROUGH  
INCLEMENT WEATHER COORDINATOR**

**WHEREAS**, the Borough of Trappe is responsible for insuring public safety of its residents pursuant to the provisions of the Borough Code; and

**WHEREAS**, the Borough of Trappe wishes to fulfill its public safety needs for efficient administration of snow removal and salting during inclement weather events; and

**WHEREAS**, Trappe Borough Council wishes to appoint an individual as the Inclement Weather Coordinator, whose sole responsibility would be to coordinate snow plowing and salting of Borough owned roadways.

**NOW, THEREFORE, BE IT RESOLVED**, that the Trappe Borough Council hereby appoints an Inclement Weather Coordinator, whose sole responsibility will be to coordinate snow plowing and salting of Trappe Borough owned roadways with limited duties as follows:

- (a) Make contact with the snow plowing contractor for the Borough of Trappe and to coordinate snow removal and salting;
- (b) Supervise the snow plowing and salting during inclement weather events; and
- (c) Make decisions as to when snow plowing and/or salting shall begin and end and notify the snow plowing contractor of same; and
- (d) Keep records of all services performed by the snow plow contractor on forms provided by the Borough of Trappe and to submit said forms to the Borough Manager within five (5) days after any inclement weather event.

**BE IT FURTHER RESOLVED**, that the Inclement Weather Coordinator will be compensated to be on call twenty-four (24) hours a day, seven (7) days per week, for a minimum of twenty-one (21) days per month, for the six (6) month period of October through March, at the rate of \$65.00 per month. In the even the Inclement Weather Coordinator is not available for a minimum of twenty-one (21) calendar days per month, the \$65.00 per month fee will be prorated in accordance with the days available.

**BE IT FURTHER RESOLVED**, that the Borough Council of the Borough of Trappe, County of Montgomery, does hereby appoint Clint Tichnell, a Trappe Borough resident, as the Inclement Weather Coordinator for the Borough of Trappe, for a term to expire on December 31, 2013.

**RESOLVED** and **ENACTED** this 1<sup>st</sup> day of October, 2013, by the Borough Council of the Borough of Trappe, Montgomery County, Pennsylvania.


